

Terms & Conditions for OPPO Find X8 Magic Box
Applicable for OPPO Store (web & app) account user who purchases the Find X8 Magic Box

These terms and conditions ("Terms") govern the conduct of the draw titled as **OPPO Find X8 Magic Box** (hereinafter "Contest") organized, conducted, and brought to the Participant(s) by OPPO Mobiles India Private Limited ("Organizer" or "OPPO") for the promotion of **OPPO – Products**

“Participant/s” or “User/s” shall mean OPPO Store (web & app) account user who purchases the Find X8 Magic Box by paying the amount mentioned herein these Terms and then becomes eligible to get assured prize and a chance to win the contest’s main prize (as mentioned hereinbelow) between **25th Oct, 2024** till **11th Nov,2024**, (hereinafter referred to as the “Event Duration”).

1. Reward shall mean

- a) **Free OPPO Find X8 5G Coupon:** Exclusive to the Smartphone OPPO Find X8 5G, limited to 2 units. (After announcement date mentioned herein these terms, the coupon shall expire on **December 31st, 2024**)
- b) **50,000 Points:** Redeemable for any phone, audio equipment, or accessory. (Valid for one year after redemption).
- c) There is no limit to the number of OPPO Find X8 Magic Box a participant can purchase. However, participant can only avail one coupon of Free OPPO Find X8 5G on one order (multiple coupons of Free OPPO Find X8 5G cannot be applied on one order)
- d) The participants will have to be as fast as they can due to limited quantity of Free OPPO Find X8 5G Coupon.

2. Eligibility:

The Participants need to fulfill the following eligibility criteria to enter the Contest:

- a) Participant should be an individual legal resident of the Republic of India;
- b) Participant should have set India as Participant current country in Participant account settings on <https://www.oppo.com/in/store> or OPPO Store App;
- c) Participant must have a billing address within the territory of India;
- d) Participant should be of an age 18 years or above at the time of entry into the Contest; and
- e) Participant should have a valid proof of identity and age in the form of a copy of PAN Card / Driving License / Voter ID / Indian passport.
- f) Employees of OPPO, their immediate family members (spouses, domestic partners, parents, grandparents, siblings, children and grandchildren), and OPPO's affiliates, advisors, advertising/Contest agencies are not eligible to enter the Contest
- g) To join the contest, participants must purchase OPPO Find X8 Magic Box by paying ₹99 within the said timeframe of each round to become a participant of that round.
- h) Only one OPPO account per person will be eligible to participate in the Contest.

3. Timelines:

- a) The Contest follows a strict timeline, therefore Participants failing to adhere to the timeline of Event Duration shall not be considered and eventually result in cancelling of the participation.
- b) The campaign has two rounds (as mentioned hereinbelow) for the participants to participate in the contest. The overall duration of the campaign is from **25th October, 2024** starting from **12 PM** till **10th November, 2024** ending at **11:59 PM**.
- c) **Round One:**
Free OPPO Find X8 5G Coupon will be unlocked when OPPO has sold 3,000 units Magic Box by **11:59PM** on **3rd November, 2024**. Those who have purchased OPPO Find X8 Magic Box between **25th October, 2024 12:00 PM** till **3rd November, 2024 11:59 PM**, selected participants will receive a link on their WhatsApp number associated with their order on **4th November, 2024** to grab limited quantity Free OPPO Find X8 5G Coupon.

If the quantity purchased does not reach 3,000 units sold by **11:59 PM** on **3rd November, 2024** this round of activity fails. However, users who have purchased the OPPO Find X8 Magic Box, will receive 50,000 points, which will be credited to their OPPO accounts.

- d) **Round Two:**
Free OPPO Find X8 5G Coupon will be unlocked when OPPO has sold 6,000 units Magic Box from **25th October 2024** till **10th November, 2024** by **11:59 PM** (Participants who have purchased OPPO Find X8 Magic Box between **25th October 2024 12 PM** till **3rd November 2024 11:59 PM** are not eligible for this round), selected participants will receive a link on their WhatsApp number associated with their order on **11th November, 2024**. If the quantity purchased does not reach 6,000 units sold by on **10th November, 2024 11:59 PM**, this round of activity fails. However, users who purchased the OPPO Find X8 Magic Box will still receive 50,000 points, which will be credited to their OPPO accounts.
- e) Points and coupons included in the contest will be credited within 24 hours of the end of the event.
- f) If target mentioned in **Round 1** and **Round 2** is reached ahead of the schedule, the link will still be released as scheduled. For example, if the sales volume reaches 3,000 units sold on **1st November, 2024** the link will still be sent to the selected participant on **4th November, 2024**.

4. Reward Terms:

- a) The Participants playing the Contest may or may not stand a chance to win any Rewards as mentioned above.
- b) Users who purchased the OPPO Find X8 Magic Box will get an assured reward of 50,000 points.
- c) The rewards will be issued only once per user, irrespective of number of OPPO Find X8 Magic Box purchased.
- d) The Participants understand and agree that there are no guarantees that the Participants will win Free OPPO Find X8 5G Coupon. The Participants further agree that OPPO has

the right to change any of the rewards at any given point in time, at its own discretion and without any prior intimation to anyone, in any manner, whatsoever. The Participants also agree that the decision of OPPO and the terms and conditions mentioned in this Agreement shall be final and non-challengeable in respect of any of the rewards.

- e) The Participants understand that OPPO reserves the right to exclude/ cancel the participation if the participant is suspected or is in violation of any of the Terms and Conditions, tampers the products, engages in abusive, deceitful or fraudulent behavior in relation to the Contest or makes false representations or statements or violates any applicable law or regulations.

5. Redemption Mechanism/Scheme:

- a) Participants will visit OPPO Store and discover the OPPO Find X8 Magic Box banner, when they visit the web page, they can purchase the OPPO Find X8 Magic Box.
- b) The coupon will be credited to their OPPO account which they can access on <https://www.oppo.com/in/store/customer/coupons>. The participants can check the Points by visiting 'Me' and then clicking on 'My Points' in OPPO Store App or My OPPO APP. Points and coupons included in the OPPO Find X8 Magic Box will be credited within 24 hours of the end of the event.
- c) Free OPPO Find X8 5G Coupon link will be sent to user on their WhatsApp number, which was used to place the order, at the prescribed time mentioned above. Users must display speed to grab the limited quantity coupon before other participants.
- d) That for redemption of the rewards the winners must provide the details as required by OPPO for enabling the winners to avail the rewards.
- e) All Participants agree that if they fail to follow any of the redemption procedures or any additional procedures or processes advised by OPPO then they shall unequivocally and irrevocably forfeit their winnings and that OPPO shall disqualify such winners. The Participants shall not raise any dispute or challenge OPPO's decision in this regard and each such Participant shall keep OPPO completely indemnified (including but not limited for all its costs, expenses, penalties, interest, etc.) and held harmless in this regard.

The Participants hereby agree that they are providing their personal information and documents to the Organizers out of their own will, and they shall have no claims against the Organizers, or anyone associated with the Organizer for using their personal information, images and documents for any purpose connected with the Contest or in the manner prescribed under OPPO' data privacy policy mentioned herein above. 8. Confidentiality:

Notification of the 'Winner' status must be kept confidential by the Participants who have won and may be contacted/ intimated by the Organizers. The Confidentiality of winning in the Contest shall be maintained by the Participants until the Winners are publicly revealed by the Organizer otherwise OPPO, at its discretion, reserves the right to disqualify the Participants and the Participants reward shall be forfeited and the same shall be final and binding and no correspondence in this regard shall be entertained.

9. General Terms:

- a) By participating in this Contest, the Participants unequivocally and irrevocably accept the Terms of the Contest as specified herein or as may be as updated/ amended by the Organizer from time to time.

- p) Participants shall comply with these terms and conditions and waives any right to claim ambiguity in these terms and conditions and release, indemnify and hold harmless Organizer and its respective affiliates, advertising and promotion agencies, and its respective agents, representatives, officers, directors and employees from and against any injuries, losses, damages, claims, actions, or any liability of any kind resulting from or arising from this Contest or in redemption of any reward under this Contest.
- q) This Contest is not applicable to OPPO employees and their immediate relatives, OPPO distributors and dealers and their respective employees and their immediate relatives.
- r) This Contest is not applicable in State or Territory of India, where contest is prohibited under law.

10. Additional Terms

That beyond Oppo's control, security, fairness or proper play of the Contest or submission of entries. Oppo is not responsible for:

- a) lost, misdirected, late, incomplete, or unintelligible entries or for inaccurate entry information, whether caused We may, to the maximum extent permitted by applicable law and in our sole discretion, change the T&Cs or cancel the Contest at any time; or modify, terminate, or suspend the Contest should viruses, worms, bugs, unauthorized

human intervention or other causes by Participant or by any of the equipment or programming associated with or utilized in the Contest, or by any technical human error that may occur in the processing of entries;

- b) any printing or typographical errors in any materials associated with the Contest;
- c) any error in the operation or transmission, theft, destruction, unauthorized access to, or alteration of, entries, or for technical, network, telephone, computer, hardware or software, malfunctions of any kind, or inaccurate transmission of, or failure to receive any entry information on account of technical problems or traffic congestion on the Internet or at any website; or
- d) injury or damage to Participant or any other computer or mobile resulting from downloading any materials in connection with the Contest.
