

"Buy OPPO, Get UCL Viewing Event Ticket" Terms and Conditions

By participating in the **Buy OPPO**, **Get UCL Viewing Event Ticket** promotion ("the Promotion"), also known as **OPPO Invites You to Watch the UEFA Final** ("**OPPO Inawaalika Kutazama Fainali ya UEFA**"), provided by **OPPLE HUB COMPANY LIMITED** ("the Company"), participants acknowledge that they have read, understood, and agree to be bound by the following Terms & Conditions:

1. **Eligibility:** Employees of the Company, their immediate family members, advertising, promotional agencies, and suppliers are not eligible to participate.

2. Period of the Promotion and the Event

- 2.1 The Promotion begins on 13th May 2024 and ends on 1st June 2024. The Company reserves the right to change the period of the Promotion.
- 2.2 The **UEFA Champions League Final Match Viewing Event in Dar es Salaam** ("the Event") is planned to take place at 6 p.m. (EAT) 3.30 a.m. (EAT, +1 Day) on 1st June 2024.

3. How to Participate

- 3.1 Participants are eligible to receive one (1) complimentary regular ticket for the Event by **EITHER action a OR action b** below:
 - **a.** Purchasing an OPPO phone at specified OPPO Brand Shops in Dar es Salaam (Gerezani, China Plaza, Uhuru) or authorized resellers in Mlimani City Shopping Mall, Dar es Salaam (Vodashop, or Halotel Shop) within the period of the Promotion.
 - **b.** Paying a TSH 20,000 deposit at specified OPPO Brand Shops in Dar es Salaam (Gerezani, China Plaza, Uhuru) or the Company's authorized resellers in Mlimani City Shopping Mall, Dar es Salaam (Vodashop, or Halotel Shop) within the period of the Promotion. The deposit is used for a future OPPO phone purchase within the period mentioned in **clause 4.2**.
- 3.2 Tickets are subject to availability, and not all participants may receive a ticket due to limited quantities.

4. Conditions of the Voucher

- 4.1 **The Voucher**: Participants who opt to pay the deposit subject to **clause 3.1b** will receive a voucher valid for future purchase of an OPPO phone.
- 4.2 **Validity:** Valid from 2nd June through 31st December 2024 at the shop or reseller where the participant has paid the deposit.
- 4.3 **Eligibility:** Redeemable by the holder for the purchase of OPPO phones at the specified shops. Only one voucher may be used per transaction.
- 4.4 **Non-refundable:** This voucher and the associated deposit are non-refundable before, within and/or after the period of validity, unless the Event is cancelled, and/or the valid shop or reseller subject to **clause 4.2** has been closed for more than five (5) continuous working days within the valid period of the Voucher.
- 4.5 **The Event Cancellation:** In case of the Event cancellation, voucher holders may return the voucher for a refund by 14th June or choose to use it for future purchases within the validity period.
- 4.6 **Risk:** The voucher holder assumes all risk associated with the loss or theft of the voucher, as there will be no replacements or refunds provided.

5. Limitations of Liability of the Event

The Company is not the host of the Event, and not responsible for:

- 5.1 Cancellations, delays, or any changes to the event caused by factors beyond the Company's control, including but not limited to fire, epidemic, natural disasters, public emergencies.
- 5.2 Any personal injuries, death, property damage, or other damages or expenses resulting from participation in the event or acceptance, use, or misuse of the ticket.
- 5.3 Technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software.
- 6. **General Conditions:** The Company reserves the right to cancel, suspend, and/or modify the Promotion if any fraud, technical failures, or any other factor beyond the Company's control impairs the integrity or proper functioning of the Promotion, as determined by the Company in its sole discretion.
- 7. **Privacy Policy:** Any personal information collected from participants during the Promotion and/or the Event will be used solely for the purpose of administering the Promotion and/or the Event will be handled in accordance with the Company's Privacy Policy.
